



# Project: Social and Economic Impact of Covid19 on Women in the Private Sector, Two Years to the Start of the Pandemic

Client/FY: Al Quds Center for Political Studies, Funded by The Norwegian Embassy/2022

**Project Highlights:** A national level quantitative and qualitative study, Team Leader: Dr. Rana El Akhal.

**Main Tasks**: Survey tools development, enumerators training, Tech assisted field survey, piloting, field data collection, analysis of quantitative data, focus groups, dissemination workshops, qualitative data, KIIs, media coverage, recommendations to policy makers.

## **Key Stakeholders: Private Sector, Government of Jordan, UN and Int. Agencies**

The study was conducted at a **national level** covering all governorates using a combination of quantitative and qualitative study approached. It measured the impact of covid19 on women in the private sector including **businesswomen**, **informal business owners & employees**. It measured the impact at three levels; social, economic and psychological.

**Social impact:** lifestyle, family activities, social activities, childcare, responsibilities burden, mobility, harassment, violence both economic and domestic.

**Economic impact:** Household income, revenues, access to finance, unemployment and layoffs, impact on business growth, markets, contracts, business processes.

**Psychological impact:** stress levels, stability of family bonds, and future aspiration.

The study included a rich set of recommendations and suggested set of actions at short, mid and long-terms at policy level, programs level and operational reforms.



Wadi Al Mujib south of Jordan has one of the main water dams of 29.8 m<sup>33</sup>. The dam capacity decreased due to soil erosions, overgrazing and illegal water consumption by nearby farmers. The community around the damp is mostly rural tribal hosting Syrian refugees. Both, the locals and the refugees are of extremely limited income and high unemployment rates.

The project has the main aim of providing employment opportunities to both locals and hosted refugees through recruiting for the establishment of the forest on the upstream of the dam, which will also protect the soil and accordingly minimize erosion and enhance dam capacity, enhance quality of air in the area, provide grazing areas around the forest for shepherds, and provide long term economic and employment opportunities through safeguarding and maintaining the forest as well as in other tourism and recreational businesses to be created within the forest zones.





**Project Highlights:** Land area 563 square km, adjacent to Shat Al Arab, shares boarders with Iran and is a service center to oil fields, mainly the biggest oil field "Majnoon" **Main Tasks**: social study and identification of community needs, prioritization of initiatives, cost benefit analysis

Al Nashwa sub-district is a rural style area with several villages. It used to have one of the most unique species of palm trees pre the war. Majority of community members are humbly educated and skilled as farmers. The exploration of oil at Majnoon field affected the area and its community negatively due to increased pollution and lack of employment opportunities that match locals' set of competencies. The project team led by Dr. Rana El-Akhal implemented a thorough field survey segmented by age group, gender and residence area. Combined with KIIs and focus groups with community leaders and influencers to identify priority needs. The list of needs was them assessed based on weighed criteria prioritization model to identify top ranked interventions. This process was followed by cost/benefit analysis and presented to Oil Steering Committee represented by Shell company who in their turn adopted the implementation of identified top priority interventions



Al Dair district used to be an industrial area hosting paper factories. The district is also at the main highway connecting Baghdad with Basra governorate. Post the war, factories are out of order impacting unemployment. Exploration of oil in Majnoon field was accelerated influencing community lands and habitats, decreasing environmental safety and offered job opportunities that don't match the existing supply competencies and skillsets. The project team led by Dr. Rana El-Akhal implemented a thorough field survey segmented by age group, gender and residence area. Combined with KIIs and focus groups with community leaders and influencers to identify priority needs. The list of needs was them assessed based on weighed criteria prioritization model to identify top ranked interventions. 
